For security reasons, we need your signature and cannot accept requests by email. If you have more than one account number, a separate activation request is needed for each account number. To activate your SEG Federal Credit Union account E-Statement, we need your email address. It is your responsibility to provide written notification to the Credit Union of changes in your email address. To activate your Mobile Banking App you must locate the free SEG Federal Credit Union app on Google Play Store or Apple App Store.

I/we understand that it is my/our responsibility to provide written notification to the Credit Union of any change in my/our email address. I/we understand the SEG Federal Credit Union has the right to revoke any or all of the above mentioned services. You consent and agree that your use of a key pad, mouse, or other device to select an item, button, icon or similar act/action while using any electronic services SEG Federal credit Union offers; or in accessing or making any transactions regarding any agreement, acknowledgement, consent, terms disclosures or conditions constitutes your signature, acceptance and agreement as if actually signed by you in writing. Further, you agree that no certification authority or other third-party verification is necessary to the validity of your electronic signature; and that the lack of such certification or third-party verification will not in any way affect the enforceability of your signature or any resulting contract between you and SEG Federal Credit Union.
